2. Bids mailed to the Board of Lincoln County Commissioners, Post Office Box 28, Davenport, WA 99122, shall take into consideration of the mailing time process and must be received by the Commissioner's Secretary by 3:00 P.M. on Friday, May 12, 2017.

DESCRIPTION OF WORK
